Objectives and investment policy

The Fund aims to produce a positive total return (through a combination of income and capital growth). The Fund targets a positive total return in excess of LIBOR USD Overnight Rate over rolling 3 year periods regardless of market conditions. Positive total returns and the Fund's performance target are not guaranteed over rolling 3 year periods, or over any time period, and you may get backless than you invested. The Fund invests primarily in a diverse range of bonds (contracts to repay borrowed money which typically pay interest at fixed times), money market instruments (tradable securities where money can be invested for short periods) and in related derivatives (financial contracts whose value is linked to the price of an underlying asset)

These bonds may be issued by governments, institutions or companies from around the world including in emerging markets (countries that are in economic terms less developed than the major Western countries).

Derivatives may be used for investment purposes (i.e. in order to achieve the Fund's investment objectives) or for efficient portfolio management purposes e.g. with the aim of either managing the Fund risks or reducing the costs of managing the Fund.

The Fund is actively managed. This means the Investment Manager is free to select investments with the aim of achieving the Fund's objectives.

The Fund cannot replicate the target benchmark index (LIBOR USD Overnight Rate is an interbank lending rate). The Investment Manager is free to choose the investments of the Fund and these will not resemble the components of the

Risks that may not be fully captured by the Risk and Reward Indicator:

Currency exchange: Changes in the relative values of different currencies may adversely affect the value of investments and any related income.

Default: There is a risk that the issuers of fixed income investments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The worse the credit quality of the issuer, the greater the risk of default and therefore investment loss.

Derivatives: The use of derivatives may increase overall risk by magnifying the effect of both gains and losses leading to large changes in value and potentially large financial loss. A counterparty to a derivative transaction may fail to meet its obligations which may also lead to a financial loss.

Emerging market (inc. China): These markets carry a higher risk of financial loss than more developed markets as they may have less developed legal, political, economic or other systems.

Government securities exposure: The Fund may invest more than 35% of its assets in securities issued or guaranteed by a permitted sovereign entity, as defined in the definitions section of the Fund's prospectus. Currently, it is expected that the Fund will exceed this limit in securities issued by the US government.

Interest rate: The value of fixed income investments (e.g. bonds) tends to decrease when interest rates rise.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment. The entry charge shown is the most you might pay, in some cases you might pay less. You can find out actual entry charges from your financial adviser.

The ongoing charges figure shown here is an estimate of the charges. The Fund's annual report for each financial year will include detail on the exact charges made. The figure excludes any performance fee and portfolio transaction costs, except in the case of an entry or exit charge paid by the Fund when buying or selling units in another fund. 
