Objectives and investment policy

LUX IM

The Fund promotes, among other characteristics, environmental and social characteristics, provided that the target investments' issuers follow good governance practices, and qualifies under Article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosure requirements in the financial services sector.

The Fund seeks to provide capital appreciation by investing in equities issued by European companies that comply with Environmental, Social and Governance ("ESG") criteria. The Fund is managed actively and it has no reference benchmark.

The investments are selected taking into account credit analysis, financial analysis and Environmental, Social and Governance ("ESG") criteria in accordance with the ESG policy available at https://en.sycomore-am.com/Our-responsible-approach.

Consequently, an analysis based on an internal ESG rating ranging from 1 to 5 (5 being the highest rate), the SPICE rating, based on the proprietary SPICE methodology (Suppliers & Society, People, Investors, Clients, Environment), is carried out. The investment process excludes the companies involved in severe ESG controversies and/or in specific activities and/or having a SPICE rating below or equal to 3 out of 5; and selects the ones with strong business models. Screened companies are also required to meet minimum rating criteria within the Investor pillar, having a rating of the business model sub-segment above or equal to 3 out of 5.
