Objectives and investment policy

The Fund seeks an increase of the value of your investment over a long term by outperforming its benchmark. The Fund is managed actively and the composition of its portfolio may differ from its benchmark.

The Fund essentially invests in target funds invested in stocks of listed companies, bonds or short term debt instruments without any geographic or currency limitation. Investments in funds managed or promoted by Bank Vontobel AG or any other related entity may range up to 100% of its net assets. They are selected among the "best" funds with particular attention to risk diversification. Direct and indirect exposure to stocks ranges from 60% to 100% of its net assets.

The Fund may use financial derivatives to protect its portfolio against unfavorable market, interest rate or currency fluctuations. The Fund may also use futures contracts to reduce other risks or to produce more revenues.


