Objectives and investment policy

UXIM

The Fund promotes, among other characteristics, environmental and social characteristics, provided that the target investments' issuers follow good governance practices, and qualifies under Article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosure requirements in the financial services sector.

The Fund seeks to provide capital appreciation through a flexible asset allocation by selecting investments of issuers which comply with binding Environmental, social and Governance ("ESG") criteria and have solid fundamentals.

The Fund is managed actively and has no reference benchmark.

The Fund will invest, directly or indirectly through target funds (including exchange traded funds "ETFs"), in equities, bonds issued by companies, governments and supranational entities without any limitation in terms of currency, sector, market capitalization and country. The exposure to the emerging market will not exceed 30% of Fund's net assets.

The investments in target funds with equity or flexible allocation will represent at least 70% of Fund's net assets.

The selection of the target funds is based on the investment manager's assessment of and due diligence performed on the investment process applied therein with the aim to ensure the integration of binding ESG criteria on an ongoing basis, and thus will focus on ETFs on the main ESG and Sustainable and Responsible Investment ("SRI") indices aimed at including the best-in-class companies from ESG prospective; on target funds which adhere to ESG criteria and incorporate them in their investment process and decisions; on target funds whose investment strategies target specific themes related to ESG factors.

Direct or indirect investment in bonds with rating between BB+ and CCC (Standard & Poor's) or equivalent rating will not exceed 30% of Fund's net assets.

The Fund may use financial derivatives to protect its portfolio against unfavourable interest rate, market fluctuations or currency fluctuations. The Fund may also use financial derivatives to reduce other risks or to

produce more revenues. The Fund is open-ended. You may redeem shares of the Fund on any

Luxembourg business day.

The Fund has not designated a reference benchmark for the purpose of the Regulation (EU) 2019/2088.

Liquidity Risk: The Fund is invested in markets that may be affected by a decrease of liquidity. Such market conditions would impact the prices at which the Fund Manager opens and closes positions.

Counterparty Risk: The Fund may realise losses should a counterparty fail to meet its contractual obligation, especially in the case of derivatives traded Over-The-Counter (OTC).

Emerging market Risk: The Fund invests in developing overseas markets which carry a higher risk than investing in larger established markets. 
