#### Objectives and investment policy

The Fund seeks to provide capital growth over the long term by investing in a portfolio defined through a multi-factor proprietary model. The Fund is actively managed and it has no reference benchmark.

The model used to build the Fund's allocation is aimed to forecast returns on securities on the basis of fundamentals, external research inputs, external pricing sources and textual data.

The Fund will invest at least two thirds of its net assets in common and preferred stocks, warrants, rights, American and European and Global Depositary receipts ("ADRs", "EDRs" and "GDRs"). The investment in ADRs, GDRs and EDRs will not exceed 40% of the Fund's net assets.

The Fund may also invest up to one third of its net assets in non-equity securities, including short term debt instruments.

The Fund will not invest directly in securitized instruments including mortgage, asset backed securities (MBS / ABS), collateralized loan obligations (CLOs), collateralized mortgage obligations (CMOs) and CoCos.

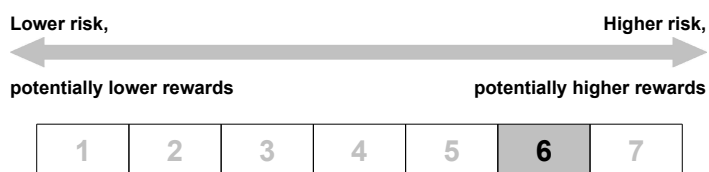
The Fund may use financial derivatives to protect its portfolio against unfavorable market or currency fluctuations.

The Fund may also use financial derivatives to reduce other risks or to produce more revenues.

The Fund is open-ended. You may redeem shares of the Fund on any Luxembourg business day.

The Share Class makes no dividend payment.

#### Risk and reward profile

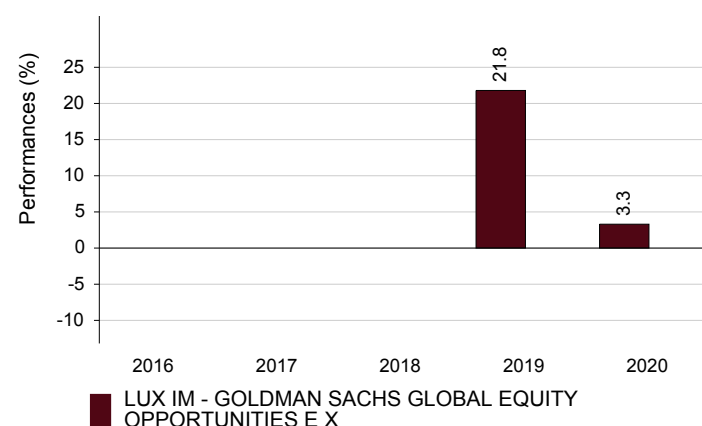
