Objectives and investment policy

The Fund aims to produce a positive total return (through a combination of income and capital growth). The Fund targets a positive total return in excess of Overnight SOFR over rolling 3 year periods regardless of market conditions. Positive total returns and the Fund's performance target are not guaranteed over rolling 3 year periods, or over any time period, and you may get back less than you invested.

The Fund invests primarily in a diverse range of bonds (contracts to repay borrowed money which typically pay interest at fixed times), money market instruments (tradable securities where money can be invested for short periods) and in related derivatives (financial contracts whose value is linked to the price of an underlying asset).

These bonds may be issued by governments, institutions or companies from around the world including in emerging markets (countries that are in economic terms less developed than the major Western countries).

The Fund may invest up to 20% of its value in mainland China.

Derivatives (financial contracts whose value is linked to the price of an underlying asset) may be used for investment purposes (i.e. in order to achieve the Fund's investment objectives) or for efficient portfolio management purposes e.g. with the aim of either managing the Fund risks or reducing the costs of managing the Fund.

The Fund is actively managed. This means the Investment Manager is free to select investments with the aim of achieving the Fund's objectives.

The Fund cannot replicate the target benchmark index. The benchmark index is not investable and therefore cannot be replicated. The Investment Manager is free to choose the investments of the Fund and these will not resemble the components of the benchmark index.

Any income due from your investment is paid out to you.

You can typically buy or sell shares in the Fund on any business day.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Currency exchange: Changes in the relative values of different currencies may adversely affect the value of investments and any related income.

Default: There is a risk that the issuers of fixed income investments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The worse the credit quality of the issuer, the greater the risk of default and therefore investment loss.

Derivatives: The use of derivatives may increase overall risk by magnifying the effect of both gains and losses leading to large changes in value and potentially large financial loss. A counterparty to a derivative transaction may fail to meet its obligations which may also lead to a financial loss.


